WHAT INFORMATION IS COLLECTED?

This Privacy Statement applies only to information collected through our Website. Our Practice collects information about you through the information you provide to us.

In order to provide you with certain services through our Website, we may collect information from you. In some cases, our Practice asks you directly for information in order for you to use our services.
